

Household Regulations

Just a few guidelines to guarantee a 100% perfect stay. Please read carefully.

Basic guidelines

- **Respect** the property as if it were your own.
- Always follow the advice and remarks of the owner or his representative about the use of the facilities.
- Make sure you take the neighbours' wishes into consideration, that means ensure a peaceful environment.
- Keep to the municipal rules, especially with regard to fire safety.

For example:

Sort your rubbish. Place the rubbish bins next to the road at the predetermined time.

Don't make excessive noise that might disturb the neighbours.

Description of the premises: at arrival and departure

True, the description of the premises can be an annoying little chore. But it is **absolutely vital** to the correct course of the stay.

Make sure to note the **description of the premises** – and the c**onsumption gauges** for water and energy – together with the owner or with the manager on site at the moment of arrival in your holiday home. Do the same thing when you leave the holiday home.



The grand majority of Ardennes-Etape's vacations pass **without a single problem**, but you cannot be sure enough. You would not want your holiday memories to be ruined by a dreadful misunderstanding.

Your responsibilities



You are responsible for the behaviour of every guest and all – if any – domestic animals. Instruct them to respect the property and to comply with the safety regulations. You are **responsible by civil law** in case of any **damage** caused by you or any of your house guests. Compensation fees will be for your account.

Because of **fi r e safety regulations** the number of guests must never exceed the **maximum capacity** of the holiday house. In case of non-compliance, the owner has the right to suspend the stay without prior notice nor compensation.



In case of accident or other problem:

Please contact as soon as possible the owner of the holiday home or the manager on site to make the necessary observations and to agree to a plan of action.

Ardennes-Etape nor the owner can be held responsible for any damage or accident caused by the incorrect use of the holiday house or any of the facilities placed at the holidaymaker's disposal.

Children's safety



Your children do not know the holiday home nor its potential hazards. It is recommended **to explore the house** together with them and to point out to them some **basic guidelines**:

- no running on the stairs;
- no playing with doors;
- no leaving the premises without adult supervision, not even to quickly go fetch a ball that landed on the road;

Never leave your kids without supervision.



If the bed linen is not included in the price you will have to bring your own sheets, mattress covers and pillowcases. Because of **hygiene** it is not allowed to sleep in your holiday home's beds without using proper bed linen.

In case of non-compliance the possible extra charges will be accounted for by the client.

Energy consumption

Be proactive and **economical with energy** in your holiday home. Use the thermostat to **regulate the temperature**.

Do not open the windows when the central heating is activated. Turn off the lights in rooms where no-one is present.

Don't waste any water.

In short, the **same little things** you do at home are just as well applicable in your holiday cottage.

Animaux :



Domestic animals are not allowed in every Ardennes-Etape holiday home. Do not bring any domestic animals if the description of your holiday home indicates that no animals are allowed. By all means respect the **safety regulations**, as well as the guidelines with regard to hygiene and house access, the home owner or the manager on site points out. Never bring more animals than allowed.

If the maximum number is exceeded, your stay can be suspended without prior notice nor compensation.

Cars, tents, mobile homes...



Parking of vehicles outside the dedicated parking space is prohibited. Tents, mobile homes, caravans or any other form of temporary lodging is strictly prohibited on the premises of the holiday home.

At departure

You are expected to leave the property in a perfect state of cleanliness after your stay.

Even if you pay for the cleaning service, you must make sure to:

- sweep the rooms;
- clean and arrange the dishes;
- clean all (electric) household appliances (including the barbecue);
- place all furniture in its original position;
- check the toilets are in a decent state;
- sort your rubbish and leave it at the right place;
- to tidy up the beds and to fold the bed linen.

Additional fees will be charged or deducted from the deposit in case of non-compliance.




Practical information

Unless stated otherwise on the holiday ticket, time of arrival or departure is as follows:



| weekend: | arrival Friday from 4 to 6 p.m. and departure Sunday before 8 p.m. |
|--------------------|-----------------------------------------------------------------------------------------------------------|
| long weekend: | arrival Friday from 4 to 6 p.m. and departure Monday before 10 a.m. |
| midweek: | arrival Monday from 4 to 6 p.m. and departure Friday before 10 a.m. |
| 1 week or 2 weeks: | arrival Friday from 4 to 6 p.m. and departure Friday before 10 a.m. |

Please take the additional guidelines from the home owner or his representative into account.
